Veteran Emphasis

As the state organization, we don't do direct hospice/clinical care. But we have had the VA reach out to different agencies and do trainings.

Our VA is a member of our hospice and palliative care coalition. We refer inquiries to them as they have now boosted their palliative and hospice care program. We had a statewide We Honor Veteran's event in November that all Oahu hospices participated in as well as the state organization. The staff at the VA invite us in to provide information statewide and they also make their trainings open to others in the state.

VA / Community interface

Again, we see the VA as the experts and refer people directly to them for all questions, including enrollment.

Business Relationship

We refer to our VA for these questions. I am not familiar with the details, just where to help people find the right people who do.

Reimbursement

So Far our Veterans have Medicare benefits and have used those benefits

We do not provide care, only referrals and information
