Veteran Emphasis

We have difficulty obtaining MD orders and if we get them verbally we have a difficult time getting them signed.

I refer to the North Dakota Hospice Organization as our state organization. It has virtually no resources or support from the state's health systems. The VA in Fargo is doing everything possible to move this initiative throughout the region. Currently, our program development is contingent upon the availability of the VA's resources.

Communication is poor from the VA outpatient staff. They often do not have the answers to questions when asked. We need a document that clearly outlines responsibilities when a VA patient is receiving hospice benefits. I recently learned that we do not need to discharge a patient from hospice if the patient is in a VA hospital for < or equal to 3 days. What are our responsibilities in this process. What is the VA responsibility?

VA / Community interface

We are excited for the next steps and committed to this partnership.

I have been listening to the We Honor Veterans Program calls, I attended the training a year ago. Quite honestly my job duties and commitments have limited my ability to work more in this area. I have however made a goal to implement more training in our agency within the next year.
