#### Heart to Heart Hospice Hosts Comedy for the Community

The We Honor Veterans (WHV) program encourages relationship building between hospice providers, the VA, and other Veteran-centric organizations. Hospice partners at each level of the program are urged to initiate and foster relationships that support their ability to provide the highest level of care to Veterans at the end of life. Level 5 WHV partners are uniquely recognized for their efforts to collaborate and engage with organizations in their community providing Veteran-focused services.

Heart to Heart Hospice of Flint, MI, a Level 5 WHV partner, utilized its many connections throughout the community to enable the success of its comedy show benefiting [Mid-Michigan Honor Flight](#). Held in early August, Heart to Heart Hospice hosted the comedy show at the local VFW hall. The event included entertainment from multiple comedians, a Veterans-only raffle, a dinner service, and sponsorships by a wide array of community partners. The success of this event is evident not only by the show's attendance and the number of community partners involved, but most importantly, by Heart to Heart Hospice's achievement of raising over \$8,000 to benefit Mid-Michigan Honor Flight!

"I had the best time and can tell you I was overwhelmed by the money raised at the event," reported Vice President of Mid-Michigan Honor Flight, Kathy Barnes.

The funds Heart to Heart Hospice raised will be used to realize Mid-Michigan Honor Flight's mission to transport Veterans to Washington, DC, to visit the memorials dedicated to honoring the sacrifices

## NEWS FROM WHV

### CMS Clarifies Services Under the Medicare Hospice Benefit for Dually Eligible Veterans

CMS recently issued [Change Request 13523](#), which updates the Medicare Benefit Manual to clarify that a Veteran beneficiary who elects hospice services under the Medicare benefit may still receive services that are not included in the hospice plan of care and are furnished and paid under the beneficiary's VA benefits, in addition to hospice services.

### Dream Foundation: Granting Dreams for Terminally-Ill Veterans and their Families

[Dream Foundation](#) is the only national dream-granting organization for terminally-ill adults. In the last 30 years, Dream Foundation has served more than 35,000 final Dreams. In 2014, Dreams for Veterans was created to tailor the Dream experience to veterans, service members, and their families. The program recently received the prestigious 2023 Fisher Service Award for its innovation and positive impact on terminally-ill veterans and their families.



Dream recipients must meet the following criteria: reside in the United States or Puerto Rico, can provide proof of U.S. military service or membership in the Reserves or National Guard, are 18 years of age or older, have been diagnosed with a life-limiting illness with a life expectancy of 12 months or less, and lack the resources to fulfill a Dream themselves.

The application process is simple! Applicants must provide a photograph, a letter describing their Dream, proof of annual income, a completed and signed Dream agreement (including medical verification completed by a treating physician or hospice representative), a completed and signed HIPPA form, and proof of military service. - The VA recently announced its [2024 Equity Action Plan](#). The plan aims to ensure that the VA delivers world-class care and benefits to all Veterans, their families, caregivers, and survivors — regardless of their age, race, ethnicity, sex, gender identity, religion, disability, sexual orientation, or geographic location.
- For the first time since the 1960s, the VA is funding new research to determine the benefits and efficacy of utilizing psychedelics to treat PTSD and depression in Veterans.
- The [2023 VA Federal Benefits Booklet](#) is available! This Booklet explains the benefits and services available to Veterans, their families, and their caregivers.
- The VA proposes a rule to improve ease of access to benefits for Veterans exposed to Agent Orange and other herbicides.
